# Letter from the Executive Director

As we launch into 2023, wildlife throughout our state faces a variety of challenges, yet momentum is being built through statewide coalitions and continued efforts to educate Hoosiers. For all of us who consume the news the situation may often seem dire. Global temperatures are rising, water patterns are changing, wildlife is disappearing, and our politicians seem unwilling, or unable to do anything about it. The flip side of the equation is not often plastered on headlines or the lead to our news broadcasts, yet a tidal wave of environmentally conscious voters is rising. Young voters and pre-voters routinely list the environment as one of their most important



issues. They prioritize public spaces and public access to land when choosing where they will live. They support businesses that hold up their value structures and shun, often vocally, those that do not. A cynic may say this is how all young people behave, over time they will change. Time will tell what comes of the belief structures of young people, but preliminary evidence shows that issues revolving around the climate and the environment are core to them and will remain so, meaning how they vote and interact with the economy will endure well into the future.

The 2023 Legislative session is nearly halfway done. A variety of bills have been put forth, while most have no direct relation to wildlife in the state, a large number do. The Indiana Wildlife Federation has identified eighteen (18) bills put forth in both the House and Senate that we believe membership and like-minded Hoosiers should be aware of. These bills include the adoption of the Governor's proposed budget that makes historic investments in the Department of Natural Resources as well as unparalleled money earmarked for land acquisition and access to public lands through Next Level Trails. Other bills are more insidious, weakening protections for wetlands and regulations throughout the state. We urge each of you to familiarize yourselves with the following bills and reach out to your elected officials and encourage them to support or oppose these bills.

Federally, a variety of important issues continue to move through the 117th Congress. 2023 will see a renewal of the Farm Bill, one of the largest pieces of legislation, and one that Indiana benefits greatly from. US Senator Mike Braun sits on the US Senate Committee on Agriculture, Nutrition and Forestry. On the House side, US Representative Jim Baird sits on the House Committee on Agriculture. The Farm Bill, authorized every five years, is the largest drivers of land-based conservation in the United States. This bill has the capacity to institute strong agricultural conservation provisions for resilient communities, healthy soils, clean water, and thriving wildlife. The Indiana delegation has the ability to influence Farm Bill priorities and you have the power to influence Senator Braun and Representative Baird to make sure Indiana's lands and water will benefit from provisions in the Farm Bill.

Locally the Indiana Wildlife Federation continues to push forward with our Sustainable Trails program. This program helps new and existing trails become thriving habitat corridors that both people and wildlife can safely enjoy. On February 25th the IWF dedicated our newest sustainable trail at the Goose Pond Fish and Wildlife Area Visitors Center along with Director Bortner and other DNR leadership. This trail will help to open up one of our state's most wonderful public lands to Hoosiers of all abilities. While the Goose Pond Trail is complete, we are just beginning construction on a new trail in Johnson County. This project, made possible through a grant from the Governor's Next Level Trails initiative, will open the Central Indiana Land Trust's (CILTI) magnificent property near Trafalgar. This state dedicated nature preserve, Betley Woods at Glacier's End, managed by our partner CILTI, is where the Wisconsin glaciation ended its southward migration when it ran into the Brown County Hills. When finished, this trail will provide multiple paths of varying difficulties, allowing nature lovers of all physical abilities to enjoy an immersion in healing properties of the natural world.

While no one can say what the rest of 2023 will bring, with the help of dedicated wildlife lovers like you we can continue to shape the future of wildlife and wildlands in Indiana.

### **IWF 2023 Legislative Priorities**

#### **State Budget - SUPPORT**

https://iga.in.gov/legislative/2023/bills/house/1001 Support the Governor's proposed budget.

#### **Watercraft Registration Renewal Fee - SUPPORT**

https://iga.in.gov/legislative/2023/bills/house/1304

This bill raises fees on watercraft registration and utilized the funds to fight invasives.

#### **Hunting and Fishing License Agents - SUPPORT**

https://iga.in.gov/legislative/2023/bills/senate/184

This bill allows businesses to tack on a \$0.75 fee for the sale of hunting/fishing licenses. We support this as it incentivises small, rural businesses to prioritize the sale of these licenses.

#### **Watershed Development Commission - SUPPORT**

https://iga.in.gov/legislative/2023/bills/house/1639

Allows municipalities to organize around watershed development. Allows the Maumee River basin commission, the St. Joseph River basin commission, or the Upper Wabash River basin commission to transform into a watershed development commission if the county executives of all participating counties, by vote of at least two of the three members of the county executive, approve the proposed transformation.

#### Closure of Coal Combustion Residuals Surface Impoundments - SUPPORT

Requires the owner or operator of certain coal combustion residuals (CCR) surface impoundments to remove all CCR from the CCR surface impoundment. This bill will NOT move, but we still believe we should take a stand. SUPPORT

#### **Duty to Notify Water Utility of Spill - SUPPORT**

Amends bill, requiring party responsible for a potentially dangerous spill to notify authorities & water utility operators if there is danger to people or the environment. This bill will NOT move, but we still believe we should take a stand.

#### **State Police and Conservation Officer Raises - SUPPORT**

Significant raises to State Police and DOC officers.

#### **Climate Change Study - SUPPORT**

Creates commission to study impact of climate change in Indiana and annually report findings and recommendations to the legislative council and the governor from December 1, 2023 to December 1, 2027.

#### **Climate Solutions Task Force - SUPPORT**

Establishes the climate solutions task force (task force) to review issues related to sustainable and clean energy solutions. Sets forth membership and requires the task force to issue a report to the general assembly and the governor not later than November 1, 2024.

#### **Climate Solutions Task Force - SUPPORT**

Establishes the climate solutions task force (task force) to review issues related to sustainable and clean energy solutions. Sets forth membership, and requires the task force to issue a report to the general assembly and the governor not later than November 1, 2024.

#### **Property Tax Assessment - SUPPORT**

Incentivizes land owners to protect wetlands through tax incentives.

#### **Natural Resources Matters - SUPPORT**

Cleans up issues with DNR's ability to operate effectively.

#### **Exception From Permitting - OPPOSE**

https://iga.in.gov/legislative/2023/bills/house/1601

Provides that a forestry operation that conducts its operations in compliance with the Indiana Logging and Forestry Best Management Practices Field Guide published by the Indiana department of natural resources is exempt from any requirement to obtain a permit from the department of natural resources or the department of environmental management concerning forestry activities confined to a waterway that has a watershed not greater than 10 square miles.

#### **DNR Best Floodplain Mapping - OPPOSE**

This bill weakens flood plain protections and will increase the risk of flooding.
