Letter from the Executive Director

Two months into 2024 and there is already so much to report regarding wildlife in Indiana. The Legislative session, a short session, is winding down, with just days remaining before they recess for the year. Throughout our state spring ephemerals are beginning to wake from their slumber, amphibians are calling from vernal pools and trees are beginning to show their buds. Above us Sandhill Cranes bugle their prehistoric call as they move north thousands of feet above the ground. While all these signs of the ever-changing seasons meld together March weather holds surprises for us, show the



seasons meld together March weather holds surprises for us, snow looms in forecasts and North bound breeders like Dark-eyed Juncos remain searching the ground for seeds to power their imminent flight to their breeding grounds North of Indiana.

The Indiana Legislative session has been a mixed bag for wildlife. Some bills have moved forward offering promise for conserving habitats so vital to the health of humans and wildlife alike. Other bills have moved ahead that continue the slow degradation of these same habitats. Below is an accounting of some of the bills we've been closely following and where they stand.

HB 1383 moved quickly through the Legislature despite a united front by environmental organizations in opposition and was signed into law by Governor Holcomb in very short order. This bill continues the weakening of wetland regulations throughout our state and shows just how insidious the recent Supreme Court decision, Sackett v. EPA is. On the other end, SB 246 breezed through both chambers and awaits the Governor's signature. This bill allows wetlands to qualify for property tax relief when enrolled in Indiana's Classified Forest and Wildlands program. This mixed bag of wetlands legislation offers both hope and concern, and IWF and our allies will continue to work to promote sound legislation that protects vital habitats for wildlife throughout our state.

One of the most controversial bills amongst conservation groups, SB 241, "Taking Bobcats," passed both houses and has been sent to the Governor. This bill bypasses the traditional rules making mechanism and instructs the Department of Natural Resources to define a season for bobcat harvest. As has always been the stance of IWF, we look to DNR to produce the scientific backing that justifies their decision, similarly to how they have managed river otters in our state with great success. SB 189, "Locating and recovering wild game," has also passed out of both chambers. This bill allows the use of unmanned aerial vehicles, drones, equipped with infrared technology to recover legally taken wild game.

The final bill of highest priority to our membership was HB 1399, "PFAS Chemicals," looked to redefine PFAS in our state. PFAS, are known as forever chemicals for their persistence in the environment. This bill would have redefined PFAS into two categories in an unscientific manner, putting our state out of step with the rest of the country with these harmful chemicals. IWF and our allied organizations lobbied hard to defeat this bill and it died in committee on the Senate side. With only a few days left in this session we are hopeful this bills language will not reemerge, yet we remain vigilant watching potential vehicle bills to ensure this harmful regulatory language remains on the sideline.

February also saw our Annual Conference, "Waterways for Indiana Wildlife" exceed all expectations, selling out and delivering a wonderful day of conservation and camaraderie. If you were unable to attend, check out these wonderful lectures on our website's video library. With our 2024 conference in the rear-view mirror, we are already looking ahead to our 2025 Annual Conference on Saturday February 8th.

As our days continue to get longer it is also time to start thinking about what we can do outdoors. IWF's annual native plant sale is up and running and offers a great opportunity to buy native plants for your specific needs. Now is a great time to help wildlife by giving them the food and shelter they need in your very own yard! Our Certified Wildlife Habitat program allows you to show that you are a supporter of wildlife, and native plants are the cornerstone to this program.

IWF staff are also busy planning programs and activities for our members. If you're looking for an eclipse viewing location, IWF will be hosting an eclipse viewing event at Holliday Park in Indianapolis. We are also finalizing the details around a day of service at Belmont Beach, along the banks of the White River in late March. Lastly, in just over a month Hoosiers throughout the state will be celebrating Earth Day. IWF staff will be fanning out over the state to participate in Earth Day activities and engage with our members. As always, you can stay up to date with our programmatic offering on our website, check them out and come out and say "Hi!"

Lastly, IWF is the recipient of a generous grant from the Walton Foundation to work on water quality in our state. We are currently hiring a motivated individual with an understanding of agriculture practices in Indiana. This role will work with the ag community to improve water quality throughout Indiana. If you know someone who is interested in working with our team have them check out this position and apply today!

The Indiana Wildlife Federation has been standing up for wildlife in Indiana since 1938, but without you we cannot do this important work. Thank you for your continued support and helping IWF continue to be the voice of wildlife for nearly a century!
